WITNESSETH:

For legal consideration to each in hand paid by the other, receipt of which is hereby acknowledged, and in consideration of the mutual covenants herein contained, the parties hereto do agree as follows;

- The information and rate sheet hereto attached is incorporated herein by reference just as though fully set forth herein.
- The Owner agrees to pay the said rate for the board of the said animal beginning with the date of this agreement, and further agrees to pay all costs and charges of and for special services listed herein or hereafter to become listed or ordered, and all veterinary costs which now or hereafter be incurred for the said animal.
- The Owner in signing this agreement and leaving his and/or her animal with the Kennel for boarding, hereby certifies to the correctness of the information given in regard to the said animal and specifically agrees to bound by the terms and conditions of this agreement and those contained on the rate and information sheet.
- The Kennel does not assume and shall not be held for any liability with respect to the animal listed and described, of any kind, character, or nature whatsoever, arising out of or from the boarding of this animal, or arising out of or from any damages or liability which may accrue from any cause whatsoever, including loss by fire, theft, running away, diseases, death, illness, injury to persons, dogs, or property or death or injury to any other animal caused by the Owner's animal during the term of this contract whether this animal be on the premises of the Kennel or not, and the owner of said animal agrees hereby to be and is solely responsible for any and all acts and behavior of said animal at any time within the term and time of the contract.
- The Kennel shall carry insurance customary for its type of operation and the Owner agrees that in no event shall the responsibility of the Kennel exceed the protection and coverage afforded by the insurance, in force at the time of the signing of this contract.
- The Owner specifically represents that he and/or she is the sole owner of the animal and that there is not now any lien or mortgage against said animal, and that the said animal has not been exposed to rabies or distemper within the last 30 days.
- The Kennel shall have and is hereby granted a lien on the aforesaid animal for any and all unpaid boarding and/or other charges resulting from the boarding of the said animal with the Kennel. The Owner hereby agrees that in the event that the boarding charges are not paid within ten days after they become due and payable in accordance with the terms of this contract, the Kennel may exercise its lien rights five days after notice to the Owner by registered mail to the address given by the Owner on the Rate and Information Sheet, may dispose of said animal for any and all unpaid charges, at private or public sale, and Owner specifically waives all statutory or legal right to the contrary and if such sales does not secure a price adequate to pay such costs of board and/or other charges delinquent plus costs of sale, the Owner shall, and must pay to the Kennel, the difference. Any monies realized by the Kennel at such a sales over and above the charges due and costs of sale shall be paid by the Kennel to the Owner.
- If the animal becomes ill or if the state of the animal's health otherwise requires attention, the Kennel shall have the right to call a veterinary or administer medicine or give other advisable attention within the Kennel's discretion, and the expense thereof shall be paid by the Owner.
- Photographs, viedotape or digital recordings are taken of the facility, dogs, customers and staff on a regular basis for, among other things, use in advertising by Animal Motel. I acknowledge that all such images (electronic, negatives and positives), together with prints and the copyrights therein, are the property of Animal Motel. I give Animal Motel and persons authorized by Animal Motel my consent, permission and authorization without compensation to me, to use, reproduce and alter the images, in print or electronic format (including on the internet), either alone or in combination with other images, text and graphics. I waive my right to approve the finished photograph, advertising copy, print material or electronic files that may be used in conjunction with the images. I represent that I am at least 18 years of age and acknowledge that the rights granted in the paragraph are irrevocable, worldwide and perpetual, and are binding on my heirs, successors and assigns.
- If any word, sentence or section of this agreement be declared invalid, such ruling nevertheless shall not affect any other word, sentence, or section. The remedies hereunder are cumulative to the Kennel and not alternative.
- No person is authorized by the Kennel to change or waive any of the terms or conditions of this contract and the Kennel will not be bound by any changes therein, whether oral or written. All terms and conditions of this agreement shall be binding on the heirs, administrators and assigns of the owner of the within animal This is of the essence hereof.
